Business Development Leader (BDL)

To become an official BDL, you will be required to apply for a designation. Establishing ECL status requires a two-day hands-on training in Atlanta. As an BDL, you will have the opportunity to supply local entrepreneurs and businesses Eco Commerce services while receiving a commission on sales. The advantage of BDL is that it does not require annual sales requirement.

Eco Commerce Leader (ECL)

(By Invitation Only to Existing BDLs Only)

As an ECL you will have a specified and protected zone in which you can operate and deliver Eco Commerce services to local customers. ECLs receive the higher percent of profit margin while being required to maintain minimum annual sales. The initial investment for an ECL is an Aggregator Eco Commerce Hub. Thereafter, the ECL will be required to deliver IMC (Integrated Marketing Communications) support and services to local entrepreneurs and businesses. Territories will be defined in each ECL contract and will provide business development protection for that region.
